


Rebuttal regarding Coal Tar Free America's "Even Seven Devils Warn Against Using Coal Tar Sealants"!

Coal Tar Sealant Warning!!
Use of Coal Tar may be hazardous
to your health and the environment.

One has to wonder what type of research the Town of Seven Devils did to slander a product on their town website. Perhaps the town took the word of the local activist without checking on the other side of the story.

A link goes on to explain make the connection that they are a near neighbor to Boone, North Carolina that earlier this year imposed restrictions on the use of coal tar sealants because of a fish kill caused by washed-off coal tar sealant. Another activist is at it again. This time it is paid activist [Donna Lisenby](#) from the Upper Watauga Riverkeepers. The Upper Watauga is part of another larger

activist group Appalachian Voices. This group in turn gets funding from Patagonia, Inc. (outdoor clothing) non-profit along with grant money from the Federal Government. This is a link to the organization's [IRS 990 Form](#) from 2009.

Items to note:

-The organization's strong [anti-coal](#) stance

-**Salaries from 2008 to 2009 increased by 22%**. Do you remember when you got you last 22% pay increase? The salaries to total contribution ratio was over 46%. That means for every \$1 you contribute, \$0.46 pays a salary in the organization.

-This organization likes to travel. It spent over \$153,000 in 2009.

-There is an expense for almost \$100,000 in 2009 under "contract labor". What could that be?

-This organization has plenty of cash on hand. At the end of 2009, the organization had \$356,520 in cash or in savings.
